Terms of Agreement

(Note – please sign the following page)

SPACE ASSIGNMENT: Show management will assign spaces based upon seniority of returning vendors, date of receipt of signed contract, and space limitations. Show management does not guarantee location. East Coast Equine will endeavor to assign requested space whenever possible. In the event that show management must reconfigure certain areas of the floor assignments, East Coast Equine reserves the right to assign an alternate space. Vendor space assignments will be assigned only upon receipt of a signed contract. Assigned vendor spaces will in no way be dependant upon vendor locations from previous or upcoming shows.

FEES: All fees are due and payable in the Show Office prior to completion of the actual show dates. Fees are \$75.00 per show day per space. Move-in day and Move-out day are included in the fees (i.e., there is no charge for move-in or move-out day).

NO VENDOR shall transfer, assign, sell, or otherwise change assigned space during show dates without the express written consent of East Coast Equine.

LAYOVERS: The responsibility of the horse show management begins and ends within the confines of the ECOSC horse show move-in date and move-out date. By signing this agreement, you agree to abide by these dates for the purposes of setting up and taking down/removing booths and displays. Any vendor laying over from one show to the next must handle that arrangement entirely through SBMEAC facility management. This includes indoor and outdoor vending areas.

THERE ARE ABSOLUTELY NO DOGS ALLOWED IN THE BUILDING AT ANY TIME. All ECOSC events are under signed contract with the Senator Bob Martin Eastern Agricultural Center to enforce this rule. Any vendor bringing a dog into the Coliseum building at any time will be asked to remove the dog or otherwise leave.

NO SMOKING is allowed in any area of the Coliseum, East Building, or Barns. This includes any inside location such as vending areas, food court, grand stands, main arena, and the paddock or staging area. All ECOSC events are under signed contract with the Senator Bob Martin Eastern Agricultural Center to enforce this rule.

PROFESSIONAL CONDUCT: Vendors and their personnel will be expected to maintain a businesslike attitude throughout the show. Anyone acting in an unprofessional, belligerent or defamatory manner towards other vendors, sponsors, exhibitors or show personnel, or conducting themselves in any manner unbecoming the Horse Show will be subject to eviction from the premises. **Under no circumstances will conduct that detracts in any way from Show Management's goal of producing a professional and enjoyable show be tolerated.**

Terms of Agreement - continued

COMPLETED CONTRACT AND VENDOR APPLICATION(S) are due to East Coast Equine no later than 8 days prior to the show move-in day, in order to be guaranteed a space. If your completed contract is not received eight days prior to show, please understand that your vendor space application will be dropped.

LATE APPLICATION: In the case that your completed contract and vendor application are not received eight days prior to the show move-in date, you may apply for remaining vending space on a first come, first serve basis as follows: Late requests must be made by phone to Trish Andrews (252-799-9342) or Norma Gurkin (252-809-3687) to ascertain the availability of vendor space. If space is available, a completed Application and Contract should then be faxed to Attn: Trish Andrews 252-799-0190 and Norma Gurkin 252-792-7660 (fax to both show managers to ensure receipt.) Please deliver the original Contract / Vendor Application to Show Management upon arrival at the show.

CANCELLATION BY VENDOR: In the case that you are not able to attend a show, but have reserved a space by means of Contract, please notify show management in person, by phone [Trish Andrews (252-799-9342) or Norma Gurkin (252-809-3687)], of your cancellation. Show management will not accept cancellation of a Vendor by anyone other than an authorized representative of the Commercial Vendor.

TERMINATION OF CONTRACT: This contract may be terminated by East Coast Equine Inc. at any time on the breach of any of the conditions stated herein by the vendor, and thereupon all Vendor's rights hereunder shall cease and terminate.

AMENDMENTS: The show management shall have full power in the interpretations and enforcement of all rules contained herein, the power to make such amendments thereto and such further rules and regulation as it shall consider necessary for proper conduct of all vendors. By signing the commercial vendor contract, the vendor agrees to abide by all rules, regulations and decisions of the show management.
